



Oxton Hockey Club 125 Club Rules

1. The name of the scheme will be Oxton Hockey Club '125 Club' Fundraising Scheme (Hereinafter referred to as the 125 Club)
2. The object of the 125 Club is to raise funds for Oxton Hockey Club (OHC) to be expended for schemes as directed by the General Committee for the further development of OHC.
3. Participation in the 125 Club is open to members of OHC and supporters. Application to participate in the 125 Club shall be made by completing the application form and returning it together with a completed standing order form to the Lead Promoter – Richard Lacey 127 Shrewsbury Road, Prenton, CH43 8SR
4. The annual cost of membership is £60 annually per allocated number payable at £5 monthly by standing order. Members may join or leave at any quarter point in any given year and will be liable to pay the relevant portion of the annual payment.
5. Each participant will be allotted his or her own individual 125 Club number which will be notified to him/her and which will be represented in each draw. Members are entitled to purchase more than one number.
6. The proceeds of the 125 Club, after deducting only expenses incurred for printing and stationery, shall be split equally between paying prizes and paying into the fund described in Para 2 above.
7. Prizes will be fixed quarterly according to the numbers of participants at the beginning of the quarter.
8. There will be two monthly prizes but these will be replaced every third month by a quarterly first and second prize. The December Draw will also have an annual jackpot prize in addition to the relevant quarterly prizes. E.g. if the club has 100 members the prizes would be as follows. Annual jackpot £1000, Eight monthly prizes two @ £40, Quarterly 1st prize of £200 and 2nd prize of £140. Prize values will be adjusted pro rata according to the number of members .
9. Only participants shown in the promoter's records (which shall be conclusive in this respect) as being fully paid up to the date of the relevant draw shall be entered in the draw. The same provision shall apply to any entitlement to vote on any matter relating to the scheme.

10. The draws will normally be held on the first Saturday of each month at Irby Cricket Club or any other venue for the time being in use by OHC as a social venue but there will be some flexibility to bring a draw into line with another function, whether at that venue or elsewhere. Quarterly draws will be held in June, September, December and March. The Annual Jackpot Draw will be held in December.
11. The promoter(s) of the 125 Club, with no fewer than two other draw scrutineers, shall meet at the clubhouse (or alternative venue) on the relevant day for the purpose of holding the draw.
12. Records of prize winners will be kept and details of prize winners will be published periodically on the club website.
13. Any amendment to these rules shall only be effected at a special meeting of participants, of which at least 14 days notice in writing must be given to each participant, by a resolution approved by a majority of those present at such meeting and entitled to vote thereat. No business shall be transacted at any such meeting unless a quorum of participants is present at the time when the meeting moves to business. The quorum shall be not less than one third of the total participants. The accidental omission to give notice of any such meeting or the non-receipt of such notice by any participant shall not invalidate the proceedings at that meeting.
14. The books and records of the 125 Club shall be inspected by the Hon Auditors to OHC.
15. The decision of the OHC General Committee shall be final in any matter regarding interpretation of these rules and all members of this committee shall be eligible to act as scrutineers at any prize draw as will team captains.
